Sealed tenders are invited for supply of ISI Quality Tarpaulins quotations in sealed cover must reach this office on or before 23.04.2018 at 02.00 PM along with EMD and the same will be opened on 23.04.2018 at 05.00 PM by the Joint Collector, Office of the Collectorate, Mahabubnagar District in presence of Tenderers or their authorized representatives.

The quotations shall be accompanied Earnest Money Deposit for Rs. 30,000/- (Rupees Thirty Thousand only) in the shape of Demand Draft obtained in favour of District Marketing Officer, Mahabubnagar District. This Agricultural Marketing Department reserves the right to reject any or all the tenders without assigning any reasons.

The terms and conditions for supplying of Tarpaulins as under:-

1. The rates should not be quoted in fraction of paise. The contractor shall quote the rate per each inclusive of all Taxes.
2. The contractor will be fully responsible to deliver the equipments in safe and sound condition till the stocks are unloaded at destination points.
3. Transportation charges should be born by the contractor only.
4. The contractor should supply the equipments from the date of finalization of tenders. If not supplied in time, the security deposit amount shall be forfeited.
5. The tender form should accompany a Demand Draft for Rs. 30,000/- (Rupees Thirty Thousand Only) towards EMD in favour of District Marketing Officer, Mahabubnagar District payable at Mahabubnagar District. The tender without EMD will be liable for rejection.
6. The Agricultural Marketing Department reserves the right to recover the damages if any due to delay in delivery of the equipments at destination.
7. In case of unsuccessful tender, the EMD will be returned after successful tenderer executes te agreement. In case of successful tenderer the EMD will be adjusted towards the security deposit when they execute the agreement.
8. Other terms and conditions will be as embodied in the form of agreement to be signed by the successful tenderer.
9. The Agricultural Marketing Department reserves its right to conduct negotiations with any tenders, if necessary before the finalizing the contract.
10. The Agricultural Marketing Department reserves its right to reject any or all the tenders without assigning any reason. The Agricultural Marketing Department is not bound to accept the lowest tender.

11. The Agricultural Marketing Department reserves its right to award contract in full or part to one or several parties.
12. The Tenders should be strictly in conformity with the prescribed terms and conditions. Tender should not contain any condition other than the prescribed.
